Changes have been made to the following section, the language below replaces the language in the IFB:

III. SCOPE OF WORK / SPECIFICATIONS

11. The contractor is **NOT** responsible for repair of irrigation system unless repair is needed due to contractor damage. Irrigation repairs will be handled separate from the contract. The awarded contractor may be asked to quote any needed repairs but the College will have sole discretion in deciding what vendor will perform the services.

All other terms and conditions of GTC 21-09-279IFB remain the same.

Following are the Questions received and Answers:

1. The SOW does not mention any turf care applications, e.g., fertilization or weed control, etc. Is this accurate?

Answer: Turf fertilization, post emergent turf weed control and pre-emergent turf weed control **ARE NOT** a part of this solicitation.

- 2. The SOW does not allot for fescue seeding and aeration. Is this accurate? **Answer:** Yes.
- 3. Aside from contractor damage, are irrigation repairs billable or need to be included in the bid? Answer: See Change noted above. The contractor is <u>NOT</u> responsible for repair of irrigation system unless repair is needed due to contractor damage. Irrigation repairs will be handled separate from the contract. The awarded contractor may be asked to quote any needed repairs but the College will have sole discretion in deciding what vendor will perform the services.
- 4. How many irrigation zones are there on the property?

Answer: 44 zones
