\_\_\_\_\_ **I am an emancipated minor.** **Documentation:** Attach a copy of the court's decision that you are or were an emancipated minor before the legal adult age in your state. The court must be located in your state of legal residence at the time the court's decision was issued. If the court order is no longer in effect, you are not an emancipated minor.

\_\_\_\_\_ **I am in legal guardianship.** **Documentation:** Attach a copy of the court's decision that you are or were in the custody of a legal guardian prior to the legal adult age in your state.

\_\_\_\_\_ **I am homeless.** **Documentation:** Attach a copy of the determination made by a school from a counselor, the school district homeless liaison or director of an emergency shelter program funded by the US Dept of Housing and Urban Development (HUD) that you are an unaccompanied youth (under age 22) who is homeless.

\_\_\_\_\_ **I am at risk of homelessness.** **Documentation:** Attach a determination letter from the director of a runaway or homeless center or transitional living program that you are an unaccompanied youth (under age 22) who is homeless or is self-supporting and at risk of being homeless.

\_\_\_\_\_ **I made an error on my FAFSA.** I am not an orphan, a ward of the court, emancipated minor, in legal guardianship, homeless, or at risk of being homeless. **Requirement:** Correct the information on your FAFSA by providing your parent(s) demographic and financial information.
