## 2017-2018 QUESTION 23 STUDENT AID ELIGIBILITY WORKSHEET

You are receiving this worksheet because you reported on your Free Application for Federal Student Aid (FAFSA) that you had a conviction for possessing or selling illegal drugs **or** because you left **Question 23** blank. **Complete this worksheet to determine if you are eligible for federal student aid and return immediately.**

*These are the possible eligibility results:*

**"1"** means your eligibility for federal student aid is not affected by Question 23.

**"2"** means your drug conviction(s) affect eligibility for federal student aid for part of this school year. The Financial Aid Office will examine your "eligibility date" from question 11 on this worksheet to determine your status.

**"3"** means you are not eligible for federal student aid for this school year unless you complete an acceptable drug rehab program or pass two unannounced drug tests administered by an acceptable drug rehabilitation program.

**Even if you are not eligible for federal student aid, you may still be eligible for aid from your state or college.**

**On this worksheet count only federal or state convictions. Do not count any convictions that have been removed from your record, or occurred before you turned 18, unless you were tried as an adult.**

**Instructions:** Check Yes or No answers and indicate dates when asked.

1. Have you ever received federal student aid? (Federal grants, loans, and/or work-study)  
 **No** If No, sign and return worksheet to GTC's Financial Aid Office  
 **Yes** If Yes, go to question 2.
2. Have you ever been convicted of selling or possessing illegal drugs (not including alcohol or tobacco) while you were receiving federal student aid?  
Only include federal and state convictions. Do not include convictions removed from your record or that occurred before age 18 unless you were tried as an adult.  
 **No** If No, sign and return worksheet to GTC's Financial Aid Office  
 **Yes** If Yes, go to question 3.
3. Did the offense for possessing or selling illegal drugs occur during a period of enrollment for which you were receiving federal student aid (grants, loans and/or work-study)?  
 **No** If No, sign and return worksheet to GTC's Financial Aid Office  
 **Yes** If Yes, go to question 4.
4. Have you completed an acceptable drug rehabilitation program since your last conviction?  
*An acceptable drug rehabilitation program must include at least 2 unannounced drug tests, and: (1) be qualified to receive funds from a federal, state, or local government or from a federally-or state-licensed insurance company; or (2) be administered or recognized by a federal, state, or local government agency or court, or a federally-or state-licensed hospital, health clinic, or medical doctor.*  
 **Yes** If Yes, your answer to Question 23 is "1", sign and return worksheet.  
 **No** If No, go to question 5.

5. Do you have more than two convictions for **possessing** illegal drugs while receiving federal student aid?  
 **Yes** If Yes, your answer to Question 23 is "3", sign and return worksheet.  
 **No** If No, go to question 6.

6. Do you have more than one conviction for **selling** illegal drugs while receiving federal student aid?  
 **Yes** If Yes, your answer to Question 23 is "3", sign and return worksheet.  
 **No** If No, go to question 7.

7. Write the date of your last conviction for **possessing** drugs here:  
*If you have no convictions for possessing drugs, skip to question 9.*

- If your eligibility date in question 11 is **between July 1, 2017 and June 30, 2018**, your answer to Question 23 is "2," sign and return this worksheet to GTC's Financial Aid Office.
- If your eligibility date in question 11 is **after June 30, 2018**, your answer to Question 23 is "3," sign and return this entire worksheet to GTC's Financial Aid office.
