

The U.S. Department of Education requires that all male students born before 1960 be registered with Selective Service before they are eligible to receive any federal financial aid. Almost all male U.S. citizens regardless of where they live, and male immigrant aliens residing in the U.S., are required to be registered if they are at least 18 but are not yet 26 years old. Men who are 26 years old and older are no longer eligible to register.

  - I was hospitalized, incarcerated, or institutionalized while I was age 18 - 25. (Provide proof to the Financial Aid Office.)
  - I am enrolled in an officer procurement program at The Citadel, North Georgia College and State University, Norwich University, Virginia Military Institute, Texas A&M University, or Virginia Polytechnic and State University. (Provide proof.)
  - I am a Commissioned Public Health Service officer on active duty or a member of the Reserve of the Public Health Service on specified active duty. (Provide proof of service.)
