## **I. SCOPE OF SOLICITATION**

### **ACQUIRE SUPPLIES / EQUIPMENT (JAN 2006):**

The purpose of this solicitation is to acquire the supplies/equipment complying with the enclosed description and/or specifications and conditions. [01-1005-1]

The term of the initial contract is one year as stated in the award notice. The maximum value of this contract is \$50,000. There is no guarantee of scheduling of service needs or minimum dollar payment in this contract, as it is on call services on as needed basis. The term of this contract may be renewed for up to 4 additional, 1 year contracts, or up to the maximum contract value.

## **II. INSTRUCTIONS TO OFFERORS – A. GENERAL INSTRUCTIONS**

### **DEFINITIONS, CAPITALIZATION, AND HEADINGS (FEB 2015)**

AMENDMENT – means a document issued to supplement the original solicitation document.

AUTHORITY means the State Fiscal Accountability Authority or its successor in interest.

BUSINESS means any corporation, partnership, individual, sole proprietorship, joint stock company, joint venture, or any other legal entity. [11-35-310(3)]

CHANGE ORDER - means any written alteration in specifications, delivery point, rate of delivery, period of performance, price, quantity, or other provisions of any contract accomplished by mutual agreement of the parties to the contract.

CONTRACT - See clause entitled "Contract Documents & Order of Precedence."

CONTRACT MODIFICATION – means a written order signed by the Procurement Officer, directing the contractor to make changes which the changes clause of the contract authorizes the Procurement Officer to order without the consent of the contractor.

CONTRACTOR - means the Offeror receiving an award as a result of this solicitation.

COVER PAGE – means the top page of the original solicitation on which the solicitation is identified by number. Offerors are cautioned that Amendments may modify information provided on the Cover Page.

**III. SCOPE OF WORK / SPECIFICATIONS**

Greenville Technical College (GTC) is soliciting for a Fixed Price Bid contract for on-call unarmed personnel to staff the GTF Student Housing Station (aka) Housing Checkpoint. Each shift will be an 8 hour shift for any of the following days and hours: Sunday through Saturday, 8:00 AM to 4:00 PM, 4:00 PM to midnight, or midnight to 8:00 AM.

The on-call contract is to fill staffing needs for regular GTC Campus Safety personnel who are absent from their duty post due to sickness or other reason. This contract does not constitute, nor does it imply a job with Greenville Technical College or the State of South Carolina. These services are contract temporary only. Staffing is provided only for the Housing Checkpoint located on the Barton Campus of Greenville Technical College 506 S. Pleasantburg Dr. Greenville, SC 29607.

The personnel staffing the Housing Checkpoint will be under the direction of the college's Environmental Health Manager.

Personnel staffing the Housing Checkpoint will report for duty in a state of "fit for duty"\*\*, appropriately dressed, perform in a professional manner, enforce Checkpoint rules and regulations, be courteous to students and visitors of the GTF Student Housing Complex and follow all prescribed rules, regulations, and procedures of Greenville Technical College (GTC), Greenville Tech Foundation (GTF), State of South Carolina, and Checkpoint, without substitution unless directed otherwise by the GTC Environmental Health Manager, Director of Facilities for Greenville Technical College, the VP for Finance of Greenville Technical College or designee.

Temporary staffing personnel are responsible for providing their own uniforms, including cold and rainy weather clothing. GTC does not furnish any uniforms or accessories to temporary staffing personnel. Temporary staffing personnel may operate and use equipment located in/at Checkpoint. Adequate training in Checkpoint responsibilities and procedures will

be provided to temporary staffing personnel. Temporary staffing personnel must be trained prior to reporting for duty at Checkpoint.

Temporary staffing personnel reporting for assignment in a state of “unfit for duty” will be immediately dismissed and will be promptly replaced by an individual the contractor deems is “fit for duty”. Replacement must be made by the staffing company within a two (2 hour) window at the scheduled rate when the unfit for duty person was call-in. Should Temporary staffing individuals be dismissed for cause, they may not be permitted to return to work at Greenville Technical College.

\*\* Fit for Duty means an individual who is coherent, not under the influence of alcohol, illegal substances, medication that impairs an individual’s judgement, vision, hearing or mobility; an individual that has the physical capabilities to perform the written duties and responsibilities of the post.

Holiday work as indicated in the bidding schedule are: New Year’s Day, Martin Luther King observed holiday, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, Christmas Day and Christmas Eve.

### **Checkpoint Duties**

The specific duties of the Checkpoint area as follows and are incorporated into this contract document. All procedures are required to be follow by personnel staffing the Checkpoint. Alterations/exceptions are not permitted except as listed above. Greenville Technical College reserves the right to modify procedures as needed. Should procedures be modified, Greenville Technical College will inform the contractor and staffing company so that follow-up training with temporary staffing personnel may be conducted.

### **Residents and staff**

All residents and staff of the GTF Housing complex are issued IDs.

All housing residents and staff, Greenville Technical College employees, Greenville Tech Foundation employees, and Campus Pointe management employees are required to show their ID upon entering the Checkpoint – NO EXCEPTIONS.

No altered form of an ID is permissible, e.g. photograph of ID via phone or other electronic device, or photocopy.

Residents without an ID will be treated as a visitor to the complex. They must surrender their driver’s license or other form of government issued ID, until they return with their Resident ID.

### **Vehicles**

Residents and or employees driving into the complex must stop at Checkpoint, present their ID, and be permitted to enter the complex after vehicle is checked for a valid Faculty/Staff or Housing parking decal. Exceptions – emergency vehicles, Greenville Technical College Grounds and Maintenance equipment, and sanitation/trash services.

Vehicles without a valid Housing Complex or faculty/staff parking decal must park in the guest parking lot adjacent to Checkpoint.

Residents entering the Housing Complex with others in their vehicle must remained stopped at the Checkpoint until all occupants show their Resident ID. Visitors must be registered on the Visitor’s Log and surrender their driver’s license or other Government issued ID to the Checkpoint personnel until they depart the Housing Complex.

Vehicles with tinted windows must be lowered completely, regardless of weather conditions, so that all occupant IDs are verified before the vehicle is permitted to enter the complex.

Waive-through of individuals entering the Housing Complex is only permitted to first responders including Greenville City Fire, Greenville County EMS, Greenville City Police, or Greenville Tech College Police. First responders are not required to show their IDs while responding to an emergency.

Delivery drivers, such as USPS, UPS, and FedEx, must surrender their driver’s license and sign in as a visitor on the Visitor’s Log. Their driver’s license will be returned upon exiting the Checkpoint. Food delivery and Taxi driver services may not enter the Housing Complex. They are the responsibility of the resident and should be met by the resident in the guest parking lot adjacent to Checkpoint.

Maintenance and Grounds service vehicles not affiliated with Greenville Technical College, Greenville Tech Foundation, or the Campus Pointe management company must surrender their ID to Checkpoint personnel and will be logged in/out on the visitor's log.

Vehicles not belonging to a resident or staff will be required to park in the guest parking lot adjacent to Checkpoint.

Residents accompanying guests in a non-resident vehicle, such as that of a parent or relative, may be permitted into the Housing Complex to unload groceries, laundry, etc. for a brief time not to exceed 15 minutes. All visitors inside the vehicle are required to be logged in on the Visitor's Log. All visitors over the age of 18 must surrender their driver's license at time of check-in. Afterwards, the visitor's vehicle must return to the guest parking lot adjacent to Checkpoint. Violations will be reported to the appropriate Resident Assistance (RA) or Housing Complex Manager listed in the Checkpoint.

### **Visitors**

All visitors must accompany the student housing resident at all times while inside the Housing Complex.

Visiting hours to the Housing Complex are:

Monday – Thursday – 9:00 AM to midnight;

Friday and Saturday – 9:00 AM to 2:00 AM;

Sunday – 9:00 AM to 12:00 AM

No overnight visitors are permitted unless approved in advance by the Housing Complex management staff. A list of all overnight visitors will be submitted to Checkpoint personnel. Should a visitor fail to sign-out by the designated curfew time, Checkpoint personnel must contact the on-call Resident Assistance (RA) so that the visitor may be found and escorted off the Housing Complex.

Visitors under the responsibility of the resident must be 17 years or older. Visitors under the age of 17 must be accompanied by a parent or Guardian.

Only same gender visitors are permitted for overnight stays unless the visitor is a relative of the resident (mother, father, aunt, uncle, nephew, niece, brother, sister, uncle, aunt, grandparent, or legal guardian). During regular visitation hours, opposite gender visitors may be permitted in the Housing Complex.

All visitors will sign the Student Housing Visitor's log upon entry and surrender their driver's license or government issued ID to the Checkpoint Safety Officer.

Upon departure, the visitor must sign-out at Checkpoint. At this time their driver's license or government ID will be returned to them.

### **Miscellaneous**

Checkpoint staffers will exit the enclosure to check all IDs in any vehicles entering through the Checkpoint at all times.

No loitering is permitted at the Checkpoint.

No mail or packages are to be left at the Checkpoint. Delivery should be made to the Housing Clubhouse only.

No firearms are permitted into the Housing Complex.

No tobacco use is permitted at the Checkpoint.

Contact Greenville Tech Police (864) 250-8911 in case of criminal activity, emergency, or damage to Checkpoint.

Contact Greenville Tech Police (864) 250-8911 in the event of a vehicle accident at Checkpoint or inside the Housing Complex.

No wreckers or repossession services are permitted into Housing Complex at any time.

If a resident's vehicle is in need of battery jump, flat tire fix, etc. they are to notify Checkpoint and meet the repair service visitor at the Checkpoint. If a vehicle must enter for service, they will be signed in as a visitor under the aforementioned visitor rules.

Only the Procurement Officer has actual authority to waive any of the State's rights under this Contract. Any waiver must be in writing. [07-7A095-1]

**VII. TERMS AND CONDITIONS – B. SPECIAL**

**CHANGES (JANUARY 2006)**

(1) Contract Modification. By a written order, at any time, and without notice to any surety, the Procurement Officer may, subject to all appropriate adjustments, make changes within the general scope of this contract in any one or more of the following:

- (a) drawings, designs, or specifications, if the supplies to be furnished are to be specially manufactured for the [State] in accordance therewith;
- (b) method of shipment or packing;
- (c) place of delivery;
- (d) description of services to be performed;
- (e) time of performance (i.e., hours of the day, days of the week, etc.); or,
- (f) place of performance of the services.

Subparagraphs (a) to (c) apply only if supplies are furnished under this contract. Subparagraphs (d) to (f) apply only if services are performed under this contract.

(2) Adjustments of Price or Time for Performance. If any such change increases or decreases the contractor's cost of, or the time required for, performance of any part of the work under this contract, whether or not changed by the order, an adjustment shall be made in the contract price, the delivery schedule, or both, and the contract modified in writing accordingly. Any adjustment in contract price made pursuant to this clause shall be determined in accordance with the Price Adjustment Clause of this contract. Failure of the parties to agree to an adjustment shall not excuse the contractor from proceeding with the contract as changed, provided that the State promptly and duly make such provisional adjustments in payment or time for performance as may be reasonable. By proceeding with the work, the contractor shall not be deemed to have prejudiced any claim for additional compensation, or an extension of time for completion.

(3) Time Period for Claim. If a general aggregate limit applies, the general aggregate limit shall be twice the required occurrence limit. This contract shall be considered to be an "insured contract" as defined in the policy.

(c) Every applicable Using Governmental Unit, and the officers, officials, employees and volunteers of any of them, must be covered as additional insureds on the CGL policy with respect to liability arising out of work or operations performed by or on behalf of the Contractor including materials, parts or equipment furnished in connection with such work or operations. General liability coverage can be provided in the form of an endorsement to the Contractor's insurance at least as broad as ISO Form CG 20 10 11 85 or if not available, through the addition of both CG 20 10 and CG 20 37 if a later edition is used.

(d) For any claims related to this contract, the Contractor's insurance coverage shall be primary insurance as respects the State, every applicable Using Governmental Unit, and the officers, officials, employees and volunteers of any of them. Any insurance or self-insurance maintained by the State, every applicable Using Governmental Unit, or the officers, officials, employees and volunteers of any of them, shall be excess of the Contractor's insurance and shall not contribute with it.

(e) Prior to commencement of the work, the Contractor shall furnish the State with original certificates and amendatory endorsements or copies of the applicable policy language effecting coverage required by this section. All certificates are to be received and approved by the State before work commences. Contractor's obligations hereunder are in no way limited by any protection afforded under workers' compensation acts, disability benefits acts, or other employee benefit acts. This clause shall not negate, abridge, or reduce any other rights or obligations of indemnity which would otherwise exist. The obligations of this paragraph shall survive termination, cancelation, or expiration of the parties' agreement. This provision shall be construed fairly and reasonably, neither strongly for nor against either party, and without regard to any clause regarding insurance. As used in this clause, "Indemnitees" means the State of South Carolina, its instrumentalities, agencies, departments, boards, political subdivisions and all their respective officers, agents and employees. [07-7B100-2]

**RELATIONSHIP OF THE PARTIES (JAN 2006)**

Neither party is an employee, agent, partner, or joint venturer of the other. Neither party has the right or ability to bind the other to any agreement with a third party or to incur any obligation or liability on behalf of the other party. [07-7B205-1]

**TERMINATION FOR CONVENIENCE – SHORT FORM (JAN 2006):**

The Procurement Officer may terminate this contract in whole or in part, for the convenience of the State. In such a termination, the Procurement Officer may require the contractor to transfer title and deliver to the State in the manner and to the extent directed by the Procurement Officer: (a) any completed supplies; and (b) such partially completed supplies and materials, parts, tools, dies, jigs, fixtures, plans, drawings, information, and contract rights (hereinafter called "manufacturing material") as the contractor has specifically produced or specially acquired for the performance of the terminated part of this contract. The contractor shall not be paid for any work performed or costs incurred that reasonably could have been avoided. As a condition of payment, contractor shall submit within three months of the effective date of the termination a claim specifying the amounts due because of the termination. The absence of an appropriate termination for convenience clause in any subcontract shall not increase the obligation of the state beyond what it would have been had the subcontract contained such a clause. Withholding Requirements for Payments to Nonresidents: Section 12-8-550 of the South Carolina Code of Laws requires persons hiring or contracting with a nonresident conducting a business or performing personal services of a temporary nature within South Carolina to withhold 2% of each payment made to the nonresident. The withholding requirement does not apply to (1) payments on purchase orders for tangible personal property when the payments are not accompanied by services to be performed in South Carolina, (2) nonresidents who are not conducting business in South Carolina, (3) nonresidents for contracts that do not exceed \$10,000 in a calendar year, or (4) payments to a nonresident who (a) registers with either the S.C. Department of Revenue or the S.C. Secretary of State and (b) submits a Nonresident Taxpayer Registration Affidavit - Income Tax Withholding, Form I-312 to the person letting the contract.

The withholding requirement applies to every governmental entity that uses a contract ("Using Entity").
