Following are the Questions received and Answers:

- Scope of Solicitation Maximum Contract Period, Page 3 confirming contract term is for one year effective 10/27/23-10/26/24 plus 4-1-year extensions?
 Yes. This bid is for one-year contract with four (4) optional one-year renewals.
 The dates provided are estimates only. The contract will begin on the date specified in the notice of award.
- 2. Price Adjustments. Page 20 would an annual price adjustment be negotiated after award? Would CPI data qualify as acceptable reason for price adjustment?

 Prices shall not be increased during the initial term. In order to be considered, any request for a price increase must be received by the Procurement Officer at least ninety (90) days prior to the expiration of the applicable term and must be accompanied by sufficient documentation, to justify the increase. CPI data can be included as part of that documentation. If approved, a price increase becomes effective starting with the term beginning after approval.
